

The purpose of this letter is to follow-up your recent phone call and my voicemail response left on our voicemail on July 11, 2018.

YOUR MESSAGE (7/10/18 @ 12:31pm): "Yes, this message is for Veronica Williams. Veronica this is calling from the Appeals Unit regarding your appeal request. I have spoken to my manager and you have stated that you have a thousand pages of documentation. We are requesting your documentation to be sent to us so that we can review it and consider it for your appeals request. I need to know how long it will take you to prepare it and send it in to me My phone number is 801-620-3331 and I will be here Thursday morning from 6:00 am 'til Noon which is Mountain Standard Time. I have also have a eFax number which is sending a fax that is 855-804-3422. Once again, we are requesting all of your documentation for consideration of your appeal request you stated that you have over 1,000 pages. We are requesting all of it."

WILLING AND READY TO FULFILL REQUEST

I will begin preparing a response to your request this weekend. I estimate it will take at least 3 weeks to compile and ship the information that I have sent or referenced to the IRS. Once I "get my arms around" what it will take to complete your request, I will confirm a delivery date.

Thank you to you and your manager for conducting such a thorough review. Other Federal Agencies, Sub-Agencies and Authorities who have requested or received information include: the U.S. Department of Justice, the U.S. Social Security Administration, the U.S. Consumer Financial Protection Bureau, the Federal Trade Commission, the U.S. General Services Administration and other sub-agencies of the U.S. Department of the Treasury. The U.S. District Court of New Jersey and multiple agencies of the State of New Jersey also have much of this information. After reviewing some of these documents, the U.S. General Services Administration settled our firms appeal in January 2018. A copy of the settlement agreement is among the documents that will be enclosed.

As a reminder, if you need more details and require that I *further waive HIPAA*¹ laws that protect my medical information, please specify in writing what additional information you require. The MIB Group (MA) and instability of the Affordable Care Act threaten health care for me and others.
