Dear Judge Salas:

We represent Defendant Stern & Eisenberg, P.C. ("S&E") in connection with the above matter. This letter shall serve as a letter application for extension of time and to withdraw the Third Motion for Extension of Time [Document 12], which application was mistakenly filed as a "motion".

A response to Plaintiff's Complaint is due by December 23, 2016, pursuant to the Court's Order granting S&E's request for an extension of time. The prior extension of time was requested because Plaintiff did not serve any of the exhibits along with the Complaint on *any* of the parties. Further, the exhibits are not available on PACER, as the docket indicates that the Complaint was filed "w/voluminous exhibits, see Court file". Consequently, our office contacted the Clerk to determine how we could obtain copies of the exhibits, but no instruction was received. Therefore, we personally appeared at the Clerk's Office yesterday, where our associate attorney conferred with Eric Underwood, Supervisor of In-Court-Activities. Mr. Underwood indicated that the file containing the exhibits could not yet be found. Given the absence of the exhibits, S&E is prejudiced and cannot meaningfully respond to the Complaint.

Respectfully, S&E requests a thirty-day extension of time to respond to the Complaint, such that it may obtain the exhibits and file a meaningful response. A proposed form of order accompanies this application.



Consent to the extension was provided by counsel for Litton Loan Servicing, HSBC Bank USA, N.A., Goldman Sachs, and Ocwen. A voicemail was left for Plaintiff, requesting her consent to the extension, but no response has yet been received.
